NOTICE OF TERMINATION OF THE SHAREHOLDERS' AGREEMENT ENTERED INTO ON 9 JUNE 2022 BETWEEN GGH-GRUPPO GENERAL HOLDING S.R.L. AND FIRST4PROGRESS S.P.A. (NOW FIRST4PROGRESS 1 S.R.L.)

Milan, 05 December 2024 - Generalfinance informs that it has received information regarding the notice of termination of the Shareholders' Agreement entered into on 9 June 2022 between GGH-Gruppo General Holding S.r.l. and First4Progress S.p.A. (now First4Progress 1 S.r.l.) (the "Agreement") sent by the shareholder GGH - Gruppo general Holding S.r.l. pursuant to article 6.1 of the Agreement. As a result of the aforementioned notice, the Agreement shall cease to be effective at the end of the 36th (thirty-sixth) month following the Trading Starting Date, i.e. on 29 June 2025.

The advertising obligations required by the applicable law for the termination of the Agreement shall be carried out in the manner and within the terms set forth therein.
